CyberSecura expands its international support offerings with the signing of its first international support contract.

As part of its international expansion strategy, CyberSecura has just signed its first ever support contract with a London-based client, thus initiating the internationalisation of its service offerings beyond the French borders.

GRENOBLE, July 28, 2021 - CyberSecura, a Grenoble-based company specialising in innovative cybersecurity and GDPR compliance advice and services, has signed its very first contract with a foreign client. This is a cybersecurity/compliance support contract with a London-based start-up whose sector of activity is now under the spotlight: social network moderation. The start-up, which specialises in A.I. and Deep Learning, uses these digital tools to moderate social content, particularly disinformation, propaganda, hate speech, etc.

A first step in its internationalisation strategy

CyberSecura is currently in the midst of an internationalisation strategy. The company plans to push its service offerings internationally, to enable more and more small businesses to engage in their security and compliance. Last month, the company joined the international incubation program FAISE to be supported in the internationalisation of its service offerings in Canada. This is an opportunity for CyberSecura to promote the expertise of French cybersecurity companies abroad. The signing of this first contract abroad is a successful first step in CyberSecura's internationalisation strategy.

The signature of this contract abroad also reminds us of the possibility for CyberSecura to provide its services in English and completely remotely. Thus, whatever the country where the company is located, CyberSecura is able to support it on its cybersecurity and/or GDPR compliance issues. CyberSecura is also able to travel around the world when necessary: for example, in 2018 CyberSecura went to Shanghai to perform a cybersecurity audit for SODEXO Ventures.

"Our model of support for small structures meets a strong need that is present everywhere, beyond borders. Our expertise, responsiveness and flexibility enabled us to win a contract despite the positioning of local competitors to our London client. This is another sign of the

strong relevance of this model and that this internationalisation will be our growth driver from 2022 onwards," explains David Rozier, co-founder and head of development at CyberSecura.
